On 25 June 2024 (after trading hours), the Company entered into a placing agreement with Wanhai Securities (HK) Limited, pursuant to which Wanhai Securities (HK) Limited has conditionally agreed, as agent of the Company, to procure, on a best effort basis, not less than six placees who and whose ultimate beneficial owners and parties acting in concert with them shall be independent third parties to subscribe for a maximum of 86,589,600 shares of the Company (the "Placing Share(s)") at the placing price of HK\$0.25 per Placing Share. The Placing Shares will be allotted and issued pursuant to the general mandate has been obtained from shareholders of the Company at the annual general meeting of the Company held on 21 June 2023. Application will be made by the Company to the Stock Exchange for the listing of, and permission to deal in, the Placing Shares. The completion of the above-mentioned placing is subject to conditions and may or may not be proceeded. For details, please refer to the announcement of the Company dated 25 June 2024.
